

Pursuant to Article 214 of the Law on Energy ("Official Gazette of RS", No. 145/14) and Article 42, paragraph 1 of the Law on Government ("Official Gazette of RS", No. 55/05, 71/05 - correction, 101 / 07, 65/08, 16/11, 68/12 -US, 72/12, 7/14-US, 44/14 and 30/18 –state law),

The Government passes a

DECREE

ON AMMENDMENT OF THE DECREE ON CONDITIONS OF DELIVERY AND SUPPLY OF ELECTRICITY

(Official Gazette of RS, No. 91/18)

The basic text in force as of 01/12/2018, in application as of 01/12/2018

Article 1

In the Decree on Conditions of Delivery and Supply of Electricity ("Official Gazette of RS", No. 63/13), after Chapter II, the Chapter IIa and Art. 17a-17d shall be added as follows:

“IIa Procedure for connection of customer’s facility to the distribution system of electricity based on a unified procedure

Article 17a

The Applicant for connection of the facility to the distribution system of electricity based on a unified procedure in accordance with the law regulating the construction of facilities is the person upon whose request the procedure for connection of the facility is initiated, within the framework of this procedure (hereinafter: the Applicant).

Alongside the notice of commencement of works for a facility that is built and connected to a distribution system of electricity, submitted in accordance with the law regulating the

construction of facilities, the Applicant shall submit to the competent authority, through the Central Information System (hereinafter: CIS), a duly completed and signed model contract for the construction of a connection to the distribution system of electricity (hereinafter: model contract), which was submitted to the applicant in the procedure for issuing the location conditions, in accordance with the law regulating the construction of facilities, i.e. the declaration of acceptance of that contract in the form of an electronic document in accordance with the law governing electronic commerce.

The model contract, in particular, contains data on: connection costs that include the costs of connection construction and part of the costs of the system resulting from the connection of the facility (hereinafter: connection costs), the deadline and method of payment and the deadline of construction of the connection and it has been prepared in the form of an electronic document, in accordance with the law governing electronic commerce.

Article 17b

On the day of payment of the amount on behalf of the costs of connection under the model contract, the obligation of the electricity distribution system operator is to start the construction of the connection, to construct the connection within the deadline for carrying out the works under the model contract, and to notify the competent authority about the completion of works on the construction of the connection, without the applicant's obligation to additionally notify the DSO of the payment made.

Article 17c

Upon completion of the facility construction, the Applicant submits a request for connection of the facility to the competent authority referred to in Article 17a paragraph 2 of this Decree by the CIS.

The request for connection referred to in paragraph 1 of this Article shall include the following as attachments:

- 1) use permit or statement of the contractor, with the confirmation of the responsible

contractor that the devices and installations are implemented in accordance with the regulations and standards applicable to the particular types of works, installations and equipment and the report on the operation worthiness of that installation, made by the contractor in accordance with an act regulating the technical conditions for low voltage electrical installations, for a facility that is connected to a voltage level up to 1 kV, or a use permit for a facility that is connected to a voltage level above 1 kV;

- 2) information on the number and date of the conclusion of the supply contract, the type of contract, the period of supply, the supplier and the end customer.

In the event that the contract on full supply has not been concluded with the end customer, in addition to the information referred to in paragraph 2, item 2) of this Article, the Applicant shall enclose also:

- 1) information on the number and date of conclusion of the contract that regulates the balance responsibility with the electricity transmission system operator and
- 2) information on the number and date of the conclusion of the contract that regulates access to the system with the electricity distribution system operator.

If the connection of the facility to the voltage level above 1 kV requires the connection of a transformer station and/or underground or overhead lines, other evidence specified in the design and connection conditions, which are obtained in the procedure for issuing the location conditions, is also required.

Article 17d

The Electricity Distribution System Operator shall, within eight days from the date of receipt of the request for connection from the competent authority through the CIS, verify the fulfillment of the conditions for connection and if all conditions are met, issue the approval that shall become effective on the date of adoption and connect the facility to the electricity distribution system.

The overall timeframe of the electricity distribution system operator for connection of the

facility is 15 days from the date of application for a connection.

The approval referred to in paragraph 1 of this Article shall include the final calculation of the costs of connection to the electricity distribution system.

In case the connection costs stated in the calculation referred to in paragraph 3 of this Article differ from the amount of connection costs paid in accordance with the model contract, the Applicant subsequently makes a payment of that difference or the operator of the distribution system of electricity makes a refund of the amount paid. "

Article 2

- 1) Procedure for connection of customer's facility to the distribution system of electricity based on a unified procedure initiated prior to the entry into force of this Decree, and in which the model contract was not submitted within the procedure of issuance of location conditions, will be continued based on the request of the applicant, to whom the electricity distribution system operation shall directly, without delay, submit the contract for signing.
- 2) In the case referred to in paragraph 1 of this Article, the Applicant shall submit to the competent authority the signed model contract, in accordance with the provision of Article 17a, paragraph 2 of this Decree.

Article 3

This Decree shall enter into force on the eighth day after its publication in the Official Gazette of the Republic of Serbia.
